### **2. Community Path:**

#### **a)Wherstead to Freston section**

MC had asked Nick Collinson to set up a meeting but, having heard nothing, contacted him again by email. NC is very busy, but is seeing Oliver Paul this week, and will discuss setting up this meeting.

Meeting with local Parish Councils: RK has spoken to David Wood, but it is Kathy Pollard who is the County Councillor with responsibility for Freston and Wherstead. RK will therefore get in touch with her, and ask her to set up a meeting with these two parishes, plus herself, the District Councillor, and ourselves.

#### **b)Shotley section**

MC attended the last Shotley Parish Council meeting to give them an update. They are still very supportive. One or two detailed queries were raised but Richard Wrinch agreed with MC that there was no point trying to deal with these points before we have the detailed map of the route. It was also agreed that the outcome of the Ganges Planning Application could have a major impact on how the path progresses.

#### **c)Ganges**

The Planning Application has been delayed by the applicants need to re-do the environmental impact assessment for the site.

On-line banking: a form authorizing on-line banking was duly signed by the banking signatories with the approval of the entire committee.

**7. Membership update:**

JG reported that 57 households have renewed, and 18 have newly joined.

RK will speak to two people who have expressed an interest in joining.

JG will circulate a definitive list of non-renewers to the committee, who will each approach an agreed selection of these people to try to get them to renew.

Matters arising: RK will get the pop-up banner to Holbrook Co-op, who have agreed to let us display it in their entrance.

MC reported on the cycling accident figures for the B1456: in the last 3-year period for which figures were available, there were 3 minor accidents involving pedal cycles (the worst of which caused a broken toe). This probably confirms that the B1456 perhaps feels more dangerous than it actually is.
